1. Each bidder should bid item wise in a separate Letterhead authenticated by the Authorized person of the Agency as follows:-

- 2. The following documents in are to be submitted in the Technical bid on e-procurement portal with the quotation failing which the tender will be considered non-responsive:
 - a) Authenticated Copy of valid enlistment letter with the Government Departments, if any.
 - b) Authenticated Copy of Certificate showing performance of this type of supply in the past
 - c) Authenticated Copy of GST, PAN No.
 - d) Authenticated Authorization from manufacturer/self manufacturing certificate for each brand quoted.
 - e) A declaration as per Annexure-II.
 - f) Bidder details as per Annexure-III with attachments.
 - g) Brand declaration as per Annexure-IV.
- 3. The bidders need not have to submit any hard copy, only the uploading of soft copies in PDF format on e-procurement portal will suffice. However, the Institute reserves the right to seek original of the documents for verification at any time during the process, failing which the bids will not be considered. There is no EMDs for this bid, however, the bidders have to submit a declaration as per Annexure-II on their letterhead mentioned below.
- 4. Rate Rates should be as per the bidders' valid price list for the year 2020-21. The successful bidders must submit <u>Three</u> copies of price list within 15 days of issue of Work Order. In view of faster communication, the bidders must mention e-mail ID, through which, the work order can be sent. The bidder must mention the details of local authorized dealer/stockiest.
- 5. Declaration of discount and brand Discount, if any for the supply of Rate Contract items should be indicated clearly by the bidders in Percentage (%) terms in the BOQ. To match the rate of discount with brand, a declaration as per **Annexure-IV** is to be submitted in the Technical Bid.
- 6. Delivery All the materials should be supplied through authorized stockiest only. Delivery should be made at ICAR-CIFRI, Barrackpore and also for its Centres/Stations located at (a) Allabahad (b) Bangalore (c) Guwahati (d) Vadodara and (e) Cochin at their premises within the stipulated time. In case additional amount is required for delivering the items at only the Regional Centres of the Institute, it should be mentioned in the prescribed cell(s) of the BOQ. It may also be noted that the Institute reserves the right to reject any bid, if the said delivery cost is found unreasonably high.

- 7. Manufacturer Guarantee In case of any manufacturing defect the materials must be replaced immediately.
- 8. GST The GST @ 5% should be separately indicated in the TAX Invoice as per Govt. of India Notification No. 45/2017-Central Tax (Rate), dated 14th November, 2017 and No. 47/2017-Central Tax (Rate), dated 14th November, 2017 for Research Institutes. A Certificate shall be issued by the Head of the Institute as per Sl. No. 3 of the aforementioned Notifications, no separate DSIR Certificate shall be issued.
- 9. Payment Payment will be made to stockiest against their bills by the Institute and other Centres located at (a) Allahabad (b) Bangalore (c) Guwahati (d) Vadodara and (e) Cochin, after satisfactory supply of the materials and quality approval. Payment by online only RTGS/NEFT on submission of Mandate form with all Bank details duly authenticated by Bank.
- 10. Liquidated damage Liquidated damage at the rate 0.5% of total Invoice amount for delay per week shall become operational, unless a specific request made for extending the date of delivery (citing validation only) is agreed upon by this Institute by writing. The supplier will be solely responsible for any loss, damage or shortage of materials in transit.
- 11. Authorized dealer The name and address of the Authorized dealer if any, may also be indicated while submitting the proposal at Annexure-III.
- 12. Jurisdiction -- For all Legal matters and disputes, if any, the jurisdiction shall be Kolkata only.
